

Single Family Rehabilitation Program with Roof-Only Option

Homeowners whose properties have fallen into disrepair may qualify for up to \$45,000 or up to \$16,500 for Roof-Only rehab assistance from the State of Illinois to improve the health and safety of their homes.

Administered by the Illinois Housing Development Authority (IHDA), the Single Family Rehabilitation (SFR) program provides grants to units of local government and community-based organizations to help incomeeligible homeowners make costly home repairs they would have otherwise been unable to afford. The program is funded through the Illinois Affordable Housing Trust Fund.

Eligible homeowners may receive up to \$45,000 to make overdue home repairs through a five-year, forgivable loan. Eligible repairs can include new roofing, flooring, electrical, plumbing or siding, as well as the removal of health hazards to improve the safety for those residing within the dwellings. Alternatively, homeowners interested only in roof repair may receive up to \$16,500 to make roof repairs through a three-year, forgivable loan.

The current funding round of the SFR program provides almost \$10 million to 21 municipalities and local agencies and will assist an estimated 299 income-eligible homeowners across Illinois.

Eligibility -

- Property must be a single-family home or condominium (mobile homes are not eligible)
- Home must be primary residence of applicant
- Household income must be at or below 80% Area Median Income (AMI)
- Property must have documented health and safety issues or concerns such as:
 mechanical, electrical, structural or plumbing that undermine the integrity of the structure
- Homes built prior to 1978 must meet lead hazard requirements

How Do I Apply?

- Simply contact one of the SFR grantees should you live in a program service area (see reverse side).
- If you currently reside in an area that is not being serviced by SFR, you may be eligible to receive assistance from a different governmental and/or not-for-profit entity. Abandoned Residential Property Municipality Relief Program

Units of local government may qualify for funds to support local revitalization efforts.

Administered by the Illinois Housing Development Authority (IHDA), the Abandoned Residential Property Municipality Relief Program ("Abandoned Property Program" or "APP") provides grants to units of local government to support local community revitalization efforts. The grant is funded through plaintiff foreclosure filing fees. The program is established by Section 7.31 of the Illinois Housing Development Act [20 ILCS 3805/7.31].

The purpose of the Program is to use moneys appropriated from the Abandoned Residential Property Municipality Relief Fund, to make grants to municipalities, counties, and land banks to assist with costs incurred for the securing, maintenance, and demolition of abandoned residential property in the jurisdiction.

Eligible Properties

- 1-6 unit residential properties in the State of Illinois
- Properties that meet the definition of "abandoned" per Program Rules
- Manufactured homes taxed as real property with a foundation and no hitch or wheels

Eligible Uses

- Cutting of neglected weeds or grass;
- Trimming of trees or bushes and removal of nuisance bushes and trees;
- Extermination of pests or prevention of the ingress of pests;
- Removal of garbage, debris and graffiti;
- Boarding up, closing off or locking windows or entrances or otherwise making the interior of a building inaccessible to the general public;
- Surrounding part or all of the property's underlying parcel with a fence or wall or otherwise making part or all of the property's underlying parcel inaccessible to the general public;
- Demolition of abandoned property; and
- Rehabilitation of abandoned property

Home Accessibility Program

Senior citizens and persons with disabilities may qualify for up to \$25,000 in assistance from the State of Illinois to improve the accessibility and safety of their home.

Administered by the Illinois Housing Development Authority (IHDA), the Home Accessibility Program (HAP) provides grants to units of local government and non-profit organizations to help income-eligible homeowners make costly repairs and modifications that increase accessibility. The program is funded through the Illinois Affordable Housing Trust Fund.

Eligible homeowners may receive up to \$25,000 to make home repairs and improvements through a fiveyear, <u>forgivable</u> loan. The mission of the program is to prevent premature or unnecessary institutionalization of senior citizens and those with disabilities. The majority of improvements must be for accessibility modifications such as making kitchens and bathrooms accessible, installing ramps, and making repairs that address safety needs.

The current funding round of the HAP program provides \$3 million to 15 municipalities and local agencies and will assist an estimated 120 income-eligible homeowners across Illinois.

Eligibility

- Property may be owner-occupied or renter-occupied residential homes or condominiums
- At least one member of the household must either be a(n):
 - Elderly person with a physical limitation
 - Person with a disability
- Household income must be at or below 80% Area Median Income (AMI)
- Modifications must meet all local, state and federal laws

How Do I Apply?

- If you currently reside in an area that is not serviced by HAP, you may be eligible to receive assistance from a different governmental and/or not-for-profit entity.
